Do you have unwanted chemicals or products in your inventory? Do you have chemical wastes in your shop or storage area?

If you answered "yes" to either question, please consider participating in the Walworth County Business Clean Sweep Program scheduled Friday, October 8.

What is a Business Clean Sweep?

Business Clean Sweep is an economical, once-a-year opportunity for a business or institution to dispose of unwanted, unused, damaged, or banned chemicals or products considered "hazardous."

What types of products are "hazardous" & need to be disposed of at a Business Clean Sweep?

- Pesticides • Herbicides • Fertilizers
- Wood preservatives • Solvents • Adhesives
- Paint remover • Antifreeze • Fuels
- Aerosols • Lubricants • Cleaning Chemicals
- Degreasers • Contaminated Absorbents
- Oil/Lead-Based Paint Product Wastes
- Fluorescent & Other Mercury-Containing Bulbs
- Mercury Thermostats

Why participate in this program? Reduced costs, and more !

- Business Clean Sweep program participants pay for product disposal, but the cost is significantly less than contracting with a vendor for this service on an individual basis. (Not all chemical or product wastes are defined as "hazardous." If your items fit some other definition, the cost may be lower than expected.)
- DATCP provides a 50% disposal subsidy for agricultural pesticides brought to this program.
- Proper chemical disposal can keep a small problem from becoming a significant liability.

Who may use the Business Clean Sweep program?

Businesses, manufacturers, schools, municipalities, & service providers that generate small amounts of hazardous waste, and classify as a Very Small Quantity Generator (VSQG) according to DNR standards. In general, any business or institution that generates less than 2200 pounds of hazardous waste per year may use this program.



What should I do, if I'm interested? (Pre-registration is required for this program.)

- ① Complete the Pre-Registration / Chemical Inventory form on the back of this brochure.
- ② Fax or mail the completed form by Friday, October 1 to Veolia ES Technical Solutions, the hazardous waste vendor contracted for Clean Sweep. Veolia will provide a **no obligation** disposal price quote. If you choose to participate, Veolia will forward additional paperwork for you to complete.

Is there a Clean Sweep for household residents & farmers?

Yes! Clean Sweep will collect hazardous waste items from Walworth County household residents and farmers on October 8 & 9. For service locations, hours, and program requirements please call (262) 741-3367.
