DAY 1: Overnight Flight to Europe/Italy

Also see the open air museum of **Piazza Della Signoria & Santa Croce**, which houses the tombs of Michelangelo and Galileo. The insightful walking tour also features a stroll across the famous **Ponte Vecchio Bridge** lined with shops. Later explore this beautiful city on your own---shop for gold jewelry & leather items and enjoy an outdoor cafe.
